**ISSUE OF AZUMAH RESOURCES LIMITED SHARES – SECONDARY TRADING NOTICE
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001
(Act)**

On 3 August 2015, Azumah Resources Limited (**Company**) issued 3,496,504 fully paid ordinary shares (deemed issue price \$0.0227) as consideration for interest due and payable in accordance with the terms and conditions of a Converting Note Agreement dated 24 January 2014 (**Securities**).

Secondary Trading Exemption
